

# Nottingham Law School Summer Schools 2020

Our exciting summer school programmes will help students develop an international perspective on legal practice and enable them to travel abroad to meet students from other universities.

### Why students should take part in a Summer School?

- Students can immerse themselves in a new culture, meet people from different universities around the world.
- They will develop key skills and experiences to add to your CV to impress future employers.
- Increase their knowledge in and around their chosen subject.

We currently run summer schools in Strasbourg, Berlin and Geneva. Students can choose to attend more than one summer school, all courses are taught in English and attendees receive a certificate from the Dean of Nottingham Law School.

#### Geneva 4th July 2020 - 11th July 2020

In Geneva the focus is on International Humanitarian Law. Students will gain an awareness of the work of the UN, Red Cross and WHO. Topics of study will include: international arbitration, health and patient safety in the developing world, religious liberty. Social and cultural activities are an important part of the visit too and the whole experience provides students with a valuable insight into international law and world affairs.

## Berlin 25th July 2020 - 1st August 2020

The focus for the Berlin programme is International Criminal Justice. Students will learn about war crimes, crimes against humanity, genocide, crimes of aggression, and victims and reparation. The programme includes a boat trip and visits to Checkpoint Charlie and Sachsenhausen Concentration Camp. #### Strasbourg 30th August – 6th September 2020

The aim of this course is to introduce you to Human Rights, and International Governanace. Human rights issues are explored primarily through a health law focus as the Council of Europe has been particularly active in that area.

#### **Visa Information**

If you are a citizen of the EU, EEA or Switzerland, you will not need visas for any of the Summer Schools. Other Nationals must check whether a visa is required. Each state may have its own rules, so do not assume that because you have visa free status in the UK that will apply elsewhere.

If you do need a visa, you will need a Schengen Visa. You must apply for this from the Embassy in London of the state you are visiting (and the main or first one in time if there are two or more). Once granted the visa is valid in all Schengen countries for its validity period (max 90 days) for multiple visits. You can apply up to three months before travelling, and are advised to do so in good time. It is YOUR responsibility to obtain the Visa. We can provide on request a letter confirming your participation in the Summer School, which is part of the application.

You should read the information provided by the various states and follow the instructions precisely. #### **Insurance Information**

Travel and Health Insurance

It is essential that you have suitable travel and health insurance. It is Nottingham Trent University policy that all students engaged in activities organised by the University have this cover. We have looked into the possibility of arranging group cover, but this has not proved possible. In any event many of you will have existing cover personally, or through a family multi-trip policy. It is therefore your responsibility to obtain suitable cover, if you do not already have it.

This policy must include the following heads of cover to the minimum amount shown:

- Medical Emergency and Repatriation Expenses. £250,000 (advised £1,000,000)
- Cancellation/Cutting Short Your Trip £500
- Travel Missed Departure Cover £500
- Loss of Important Documents (Passport, visas etc.)
- £600 Personal Liability £1,000,000

You are strongly advised to also have cover for personal property.
